Collaborative and innovative physics, dosimetry and therapy staff are assets. The FVC has a full range of medical oncology, diagnostic and support services.

BCCA-FVC Radiation Oncology is committed to excellence in clinical care and is focused on developing academic excellence in a provincial cancer care environment. The BC Cancer Agency's population-based model and resultant databases provide outstanding opportunities for outcome-based research. The FVC participates actively in clinical trials and medical teaching. The successful candidate will be expected to participate in clinical, research, administrative and educational activities.

You have obtained or are working towards Fellowship standing with the Royal College of Physicians & Surgeons of Canada in Radiation Oncology (FRCPC). You must be eligible for licensing with the College of Physicians & Surgeons of British Columbia. Faculty appointment and academic rank with UBC Medical School will be commensurate with qualifications and experience.
